

### 2019 Legislative Session Wrap Up

Aloha Friends and Neighbors,

The 2019 State of Hawai'i Legislature ended on May 2<sup>nd</sup> and I'm pleased that several of my priority bills passed and are awaiting the Governor's signature. These bills:

- Allow a one-year extension to expend flood relief funds for Kaua'i and clarify that these funds can be used for mitigation, like chopping down overgrown hau bushes on State lands;
- Add a \$200 fine to illegally parked cars on designated State highways, with half of the funds going into the State Highway fund and the other half going to the County police department where the citation is issued; and
- Provide funding to help all counties address suicide prevention, intervention, and education;

I'm also pleased the Legislature addressed key "cost of living" concerns by:

- Funding pre-school classes at 18 charter schools (facing the loss of federal funding) and 10 new public school classes;
- Funding the Promise Program which gives students, who are residents of Hawai'i attending community colleges with financial need, free tuition, books, and fees; and
- Adding \$50 million to the State's Rental Housing Revolving Fund, which helps build affordable rental housing throughout the State.

Highlighted in this newsletter are additional bills passed this Session and funds secured for District 14. While the Legislature is in recess, please reach out to me if you have a question, concern, or suggestion to improve State government. If I'm unable to answer your question, I'm happy to seek answers through State departments, agencies, and offices.

Many of the bills I introduced this session were the direct result of constituents who shared their concerns and worked with me to craft bills and advocate for them during the session. Thanks to all who actively participated in the democratic process!

I thank you for the privilege of serving you at the State Capitol. From Wailua to Hā'ena, it's an incredible honor to serve the most beautiful district in the State of Hawai'i!



### Taking Care of Our Kupuna

- **HB465**—Funds the kupuna care program that provides adult day care, personal care, and transportation for eligible, elderly residents to continue living at home.
- HB468—Funds the Healthy Aging Partnership program to improve the health and well-being of Hawai'i's kupuna. Supports Enhance Fitness and Living Well classes to manage chronic diseases.

### **Tackling Homelessness**

- **HB257**—Authorizes the use of private lands for the Ohana Zones Pilot Program and adds temporary housing alternatives with social services.
- **SB471**—Funds homelessness services, including the outreach, rapid re-housing, housing first, family assessment centers, stored property and debris removal services, and the state rent supplemental program.

### **Promoting Agriculture**

- **SB1353**—Authorizes the Department of Agriculture to make the industrial hemp program permanent and license farmers who cultivate industrial hemp.
- SB390—Promotes the purchase and consumption of locally-produced, healthy food products by Supplemental Nutrition Assistance Program participants. Requires the Department of Agriculture to develop and administer a dollar-for-dollar matching program.

### **Addressing Transportation**

- **SB162**—Increases the rental motor vehicle surcharge tax from \$3 to \$5 per day to fund projects to increase highway capacity and relieve traffic congestion.
- HB1165—Expands gender options that are displayed on a driver's license and state identification card to more accurately represent transgender and non-binary individuals (introduced by Rep. Nakamura).
- HB812—Amends the definition for low-speed electric bicycles to the definition of "bicycle" for the purposes of county vehicular taxes, highway safety laws, and statewide traffic code (introduced by Rep. Nakamura on behalf of a constituent).

### **Prison Death Transparency**

HB336—Requires the Director of Public Safety, in the event of the death of an inmate who is in a state or contracted correctional facility, to report to the Governor, who shall then report to the Legislature, certain information regarding the death (introduced by Rep. Nakamura on behalf of a constituent).

### **Protecting our Environment**

- HB1548—Appropriates funds to the Department of Land and Natural Resources to study and combat rapid 'ōhiā death in the State.
- **HB1585**—Reduce the reliance on fossil fuels by establishing a rebate program to promote the installation and upgrading of electric vehicle charging systems.

- Boys and Girls Club of Kaua'i was awarded \$200,000 for the Kapa'a Clubhouse improvements.
